

ACTELIC 50EC

A broad spectrum organophosphorus insecticide with contact, stomach and vapor action for control of wide range of pest in bulk-stored grain, bagged grain, storage surfaces. For public health, used for control of adult mosquitos and cockroaches.

Active ingredient: Pirimphos-methyl 500g/l (49.02% w/w)

Formulation: Emulsifiable Concentrate (EC)

MODE OF ACTION

ACTELIC 50EC contains pirimophos-methyl, an organo-phosphorus compound, which kills insects by contact, ingestion and fumigant action. Pirimophos-methyl as acetylcholinesterase inhibitor, causing malfunction of the nervous system.

SPECTRUM OF CONTROL

ACTELIC 50EC controls the following pests of stored grain: Saw-toothed Grain Beetle (*Oryzaephilus surinamensis*), Grain Weevil (*Sitophilus granarius*), Common Flour Mite (*Acarus siro*), Warehouse Moth (*Ephestia elutella*), Flour or Mill Moth (*Ephestia kuhniella*), Flour Beetles (*Tribolium spp.*), Rust-red Grain Beetle (*Cryptolestes ferrugineus*) and Cosmopolitan Food Mite (*Glycyphagus destructor*).

DIRECTION FOR USE.

STORED PRODUCTS

- (a) Applied in stores as pre-treatment
 - Applied on walls, floors and equipment in stores.
 - Best applied in an empty store.
 - Use 200ml of ACTELIC 50EC per 100m² in 20 liters of water
- (b) For admixture treatment, Apply ACTELIC 50EC at 8 - 10ml in 1Lt water/1000kg grain.
Spray using a suitable nozzle as the grain is fed into the bins.

PUBLIC HEALTH

- Fogging add 25ml white oil or colourless kerosene and apply as fog to treat 500m³ of air space.
- Warehouse and household control of cockroaches.
- Mosquito larvicing- control of mosquito larvae.
