RATES OF USE Sprinkle after every layer of 30-40 cm. Approximately 50gm for every two bagsful of maize cob. (Better

Shelled grain (maize, wheat and beans)
Mix 50gm for every 90kg bag of grain using a shovel. Sprinkle some ACTELLIC SUPER on the outside

of bags to reduce re-infestation.
