Fungicide for use against ringspot in carnations and botrytis in Roses; angular leaf spot on French beans and Ascochyta leaf spot on snow peas.

Mode of Action

Score 250 EC® is taken up by the plant and acts on the fungal pathogen during penetration and haustoria formation. It stops development of the fungi by interfering with the biosynthesis of sterols in cell membranes. Although the mode of action permits protective and curative use, it is recommended to apply the product early enough to avoid irreversible crop damage and build up of the disease.

Spectrum of Activity

The strength of Score 250 EC® is its excellent activity on ringspot in carnations and botrytis in Roses; angular leaf spot on French beans and Ascochyta leaf spot on snow peas.

Mixing and treatment procedure

Fill the spray tank with half the required volume of water and start agitation. Add the required amount of product and continue agitation while adding the rest of the water and during spraying.

Timing of Application

The first spray should be timed at the onset of disease development.

For ornamental diseases, a maximum of 3 time applications of Score 250 EC® are recommended as from the onset of disease. For most vegetable diseases, a maximum of 4 applications of Score 250 EC® are recommended as from the onset of disease. Use 15-20 ml per 20-litre-knapsack-sprayer (based on a water volume of 400 lt./ha).

From the point of view of anti-resistance strategy, the repeated application of straight difenoconazole should be avoided; alternations or mixtures with fungicide(s) with different modes of action are recommended.

Crop Tolerance

When used as recommended, Score 250 EC® is well tolerated by most crops it is recommended to be used on. In case of doubt, check crop tolerance in a small area before spraying a large area.

Spray volumes

Score 250 EC® can be applied with any high or medium volume ground and aerial application equipment provided with sufficient agitation. Ensure that the spray equipment is properly calibrated. Spray volume can vary between 100 and 1000 lt./ha.

Pre-harvest interval:

French Beans, Snow Peas: 14 days.

Re-entry interval:

Roses and Carnations: 6hrs.

Storage

Store in original tightly closed container away from sun and damp. Keep under lock and key, away from children, animals and other unauthorized persons.

Safety Aspects

Precautionary measures

KEEP LOCKED UP OUT OF REACH OF CHILDREN and other unauthorised persons, and animals.

Operator safety

Strictly avoid all contact of concentrate or spray mixture with skin, eyes or clothing. Avoid breathing spray mist. Prolonged or repeated exposure to product may be harmful. DO NOT eat or smoke during work; wash hands and face thoroughly first. WEAR pro-

tective clothing, i.e., overalls, gloves, gumboots and face shield. When applying indoors, wear respiratory mask, hat and goggles. Immediately wash off accidental splashes of product and spray mixture. Change contaminated clothing immediately and launder before re-use. After work wash entire body thoroughly with soap and water and change to clean clothing.

Product and Container disposal: Dispose of surplus product on a landfill site approved for pesticides or bury in a safe place away from water sources. Dilute surplus application mixture, pour it broadcast on fallow land. Dispose of plastic containers in a landfill site or burn in a safe place. Do not re-use empty containers for any other purpose, especially for food, feed or storing drinking water.

NB: Always comply with local legal requirements.

Spillage and Leakage

Remove heavily contaminated soil layer and bury in a safe place away from water sources.

Spillages: soak up with sand, sawdust, soil or an oil-binding agent. Collect up the contaminated material and dispose of in a safe place or put in a waste bin or a plastic bag, mark it and dispose of on a landfill site approved for pesticides. Treat spill area with plenty of water.

Environment and Wildlife

Non-toxic to bees. Harmful to fish. Avoid contamination of water used for irrigation or domestic purposes. No risk is expected for birds and earthworms, due to the low toxicity of the compound to these organisms. Keep all livestock out of freshly treated area.
